Thank you for allowing me to be of service.

We started November with \$9,882.74
We received group contributions of \$1,261.42
We had expenses of \$965.50
Leaving us with an ending balance of \$10,178.66

Contributions YTD are \$3,237.94 behind budget. However, we are ahead of budget expenses by

over \$7,000 YTD. I would like to urge all the committees to assess their needs and use their allocated budget(s) before year end.

In November we received a check in the mail. The check was sent in an envelope with a return address. When opened, all that was included is a check with "Donation" written in the memo line. The sender did not disclose if they are a member of A.A.

In keeping with the 7th tradition stating "Every A.A. group ought to be fully self-supporting, declining outside contributions." I did not want to deposit the check without first gathering a group conscience. My first thought is to return the check to the sender with a letter confirming that they are indeed a member of A.A., and that the check is a contribution on their behalf. (Add discussion to New Business).

The amount of the check is below the yearly \$5,000 limit to G.S.O. as well as below the lifetime maximum bequest.

When you don't turn in a report it is an opportunity lost for your group. I would suggest making your written report as long and detailed as possible. You are then given two minutes to give an oral summary during the meeting. Your full report however goes into the minutes. If we know what questions there are in advance then we can plan time around them for discussion.

- ...curious about precedent, given that the DCM is so active and involved in the community (which is appreciated), we acknowledge the financial need. That said, is it reasonable to assume the future DCM will be able to maintain that trajectory?
- -The reason the previous three years are shown is to illustrate the preCOVID expenses, the sharp decline in expenses as a direct result of COVID, and reestablishing the preCOVID expenses as the world reopens and returns to 'normal'. There is nothing included in the DCM budget that isn't part of the District Guidelines for the DCM and/or covering the normal business of the DCM. It is true that Carrie does more work than would be asked of a DCM in the normal course of a DCM term. This however is not reflected in the proposed Budget. There is no dollar amount attached to her efforts. She is rebuilding much of what existed previously but was torn down. Any subsequent DCM will have only to maintain processes. It is a gift to have her in this position at this time. -CDB
