Treasurer Report - Will D.

Greetings District 5

My name is Will D. and I am your District 5 Treasurer.

We started October with: \$8,136.87

Total contributions for the month were: \$2,235.57 Total expenses for the month were: \$489.70

Leaving us with a balance on October 31 of \$9,882.74

I owe the group an amends. Last month I reported that the DCM was over budget. I had mis-classed a few expenses to the DCM that should have been assigned to different areas of the budget. After re-classing those expenses and receiving a reimbursement for travel in September, the DCM is on budget for the year.

There is still about \$8,000 of budgeted expenses that have yet to be spent.

YTD we are \$1,841 behind in contributions. To make the 2022 budget income we need contributions for November and December to average: \$2,244.18 which is just slightly more than our rolling 3-month average.

Housekeeping items:

- Please do not send mail "Signature required," quite often I pick-up mail outside of normal post office hours. If you send your letter signature required, I am unable to pick it up.
- For groups wanting confirmation of Contribution Receipt please check the monthly financials that are posted to the District website. They show all group contributions. I highly recommend all group Treasurers reference this to confirm that their groups contributions were properly credited.
- We received a contribution from GSO group 000417097 in the amount of \$333.00. I cannot find this group on the Area 58 website. Can the GSR of this group please claim the contribution? (FOUND)
- We also have an unclaimed contribution from May Group 721992 in the amount of \$131.75

■ CTF Meeting Agenda & Minutes 2022-11-06

At our last business meeting, we reviewed and voted to approve our District 5 Guidelines. We dropped the "Format" section in lieu of the "Script" which was more concrete. We also added in a second script for online "VC/Zoom" meetings. We also approved the addition of "Our Purpose" and a "Glossary" section. We also voted to accept help and guidance from Christine, our District Secretary, to polish up the guidelines for grammar, content, etc. The updated guidelines are here:

D5 CTF Committee Guidelines (note: at the time I submitted this report, the guidelines had not received all of the approved edits)

My home group recently elected the next CTF representative to replace me in the home group commitment, which means I can devote myself to the role. One of our CTFs carrying panels into Bestcare Redmond resigned the role with no word just yet on a replacement. One new CTF representing the Page 21 group in Prineville is joining our committee. I will be meeting with her sometime next month to conduct orientation. One other possible new representative from Cyber Sisters inquired about the position. We met, conducted an orientation, and she is considering assuming the role pending Cyber Sisters' next business meeting. Also, Redmond Early Risers is interested in appointing a representative.

I've been busy with CTF outreach too. I have visited at least five other meetings in the district, including one at Rebel's Roost in Prineville, to encourage the election of CTF Home Group Representatives. I have also called at least five different treatment facilities within our district. So far I've mostly spoken with Bob at Bestcare Redmond, where we defined protocols for delivering AA panels in-person. I also chatted with Glenn at Serenity Lane in Bend, and paired him up with a facilitator that didn't have a panel. I also began a conversation with Duane at Bestcare in Prineville, but no firm progress yet. I have left voicemails and emails with others in the district as well.

Plans to visit other meetings and talk to other facilities are in the works as well. In December, after my Thanksgiving travels, I plan to visit meetings in La Pine, Madras, and possibly Warm Springs to drum up more representation.

We were also able to deliver a box of pamphlets to Bestcare in Redmond, primarily meeting directories and the typical contents of newcomer packets. Thank you Christine for your help with delivery!

Our committee approved having our business meeting every two months. Our next meeting will be on January 7th at 3pm. We hope to have more representatives show up and get some more good work done, specifically appointing a new alternate CTF chair (the previous alternate had to step down, but is continuing to run a panel) and a Bridging-the-Gap chair.

I will ask once more for any GSRs representing meetings to help get the word out! If a meeting doesn't already have a CTF representative, please make an announcement! Here's a flyer (thank you Carrie) ctf and here's the requirements CTF Group Rep (6).
