This was not something I was maliciously keeping from you. In fact, I have had sleepless nights struggling with what the right thing is to do here. I did forward you the document that came to me from our delegate the day it was sent to me. I was mistakenly under the impression that is how the A.A. service structure system works. I pass along to you only what I receive from our delegate. I was reminded by my service sponsor that I am not serving the area, or the delegate. That I am accountable to the GSRs who elected me and you are who I'm here to serve. That any credible information I receive should go to the GSRs even if I'm receiving the information in non traditional ways.

So with that, after much sponsorship-consultation and prayerful-consideration, I have come to a decision. I have decided to allow you the GSRs to decide for yourselves what information you want. I don't get to play gatekeeper. So in the Spirit of A.A. transparency and Leadership-integrity, I've created a file for you containing everything I received and as your trusted servant and I'm offering any of the GSRs access to that file upon request. I will not be including any specifics into my report. I will not be sending the documents out in the minutes or in any group email. I am not here to offer opinions about any of the documentation contained in the file. But I am offering access as the groups are on top of the triangle and should have the right to any and all documentation and information. Transparency is very important in A.A. and nothing should be confidential from the GSRs. Please forgive me for having been indecisive. I value the lesson learned and going forward I will be mindful about seeking spiritual clarity so that I may stay in alignment with the principle of integrity.

- 2. Leaders do not drive by mandate, they lead by example
- 3. Is able to exercise his own judgment.
- 4. Originates plans, policies, and ideas for the improvement of our services.

- 6. Remember that a fine plan or idea can come from anybody, anywhere.
- 7. Will discard plans for others that are better, and it will give credit to the source.
- 8. Never passes the buck. Can admit when wrong.
- 9. Does not powerdrive. Does not meekly become an order taker either.
- 10.A "politico" is an individual who is forever trying to "get the people what they want." A statesman is an individual who can carefully discriminate.
- 11. He recognizes that even large majorities, when uninformed, can, once in a while, be dead wrong.
- 12. When something vital is at stake, it is the duty of leadership, even when in a small minority, to take a stand against the storm, using its every ability of authority and persuasion.

- 21. Able to recognize that our talents vary greatly. One member will have different strengths than the next member. Everyone is not meant to do everything. But there's something for everyone to do.
