Lots of activity in Corrections since last report. County Jails have started or are preparing to start in person meetings.

Deschutes County Jail - Bend Contacted Programs Director Deputy, who had just rotated in the position. Their schedule is to start in person meetings in May. In preparation for that, new applications need to be in by April 21 and interviews in May. All new applicants and existing volunteers are going to be required to attend the 8-hour orientation for all jail Volunteers (AA, NA, Religious, etc.) Sent the following Literature package to them. GV Prison Issue July 2019 o Cost \$289.90 Sent text messages to 56 Volunteers currently listed to see if they wanted to continue or be removed from list. To date received 37 responses (66%), 15 have moved or otherwise want to be removed, 22 want to continue. Recruiting o Have been going to different meetings to recruit new volunteers. So far have sent out 9 applications, none returned yet. Typically only half end up as Volunteers, so more are needed, but I can't go to all meetings. o With April 21 deadline would like if GSR's could help by announcing Corrections Volunteer Opportunities in their meetings. The commitment is going into the jail 2 hours once a month or being in reserve. Thank you. I expect application and instructions to be on D5 website soon.

Jefferson County Jail – Madras Contacted Jail Volunteer coordinator. They are making plans for in person meetings but no date yet. Asked for and received their Volunteer Application which will b on D5 Website soon. As with Deschutes County they want to do a "refresher" orientation. He agreed to receive Literature package as above and ordered same. Contacted AA Member Rick U, asked and he agreed to be D5 Corrections Committee contact for Jefferson

County Crook County Jail – Prineville Contacted Jail Coordinator. She seemed suspicious of me and why I had contacted them, like I was a salesman and wanted to get rid of me. Meetings seemed sporadic which is understandable as they are new to them. I offered to send literature, which was refused. Contacted AA Member Mark L, asked and he agreed to be D5 Corrections Committee contact for Crook County. I told him about the Literature and it was agreed to send the literature package to him and Members there would bring into the jail. I asked for an application to post on D5 website, but haven't received yet.
