#### **Tradition 8 Presentation:**

<u>The Eighth Tradition</u>: Alcoholics Anonymous should remain forever non-professional. *We define professionalism as the occupation of counseling alcoholics for fees or hire.* But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. "12th Step" work is never to be paid for.

"This does not mean, of course, that the idea of turning professional has never entered any A.A.'s mind. In the lean years, Bill W. did think of becoming a lay therapist to earn money through his experience in helping alcoholics. But, with a strong nudge from the group conscience... It became clear to the early members that no A.A. should ever ask or accept payment for "carrying this message to somebody else, person to person and face to face. -The TWELVE TRADITIONS Illustrated

"Tradition 8 says that "Alcoholics Anonymous should remain for a non-professional, but our service centers May employ special workers."

Alcoholics Anonymous will never have a professional therapeutic class. We have gained some understanding of the ancient words "Freely you have received freely give." For our purpose, we have discovered that at the point of professionalism money and spirituality do **not** mix. We do not describe professionalism in other fields, but we accept the sober fact that it does not work for us. Every time we have tried to professionalize our 12th step, the result has been exactly the same; our single purpose has been defeated.

You remember how I was told by A.A.'s group conscience that I could not work for Charlie towns as a professional therapist, and that was right. Early in the game we discovered that under no conditions should an AA be paid for taking or carrying this message to someone else, person

to person and face to face. That was out. If professionalism ever invaded us at that level, we were doomed.

#### Treasurer Report - Will D.

Good afternoon District 5, my name is Will, and I am an alcoholic. My sobriety date is November 21, 2018, and my home group is New Horizons.

Today we will be reviewing the July 2023 Financials. I emailed this to the Secretary, and they will be posted to the District 5 website. We are reviewing July 2023 which runs July 1, 2023, to July 31, 2023.

We will start with the first line on the upper left-hand side of the Treasury Summary, but first let's go over some definitions of the titles used in this table.

- "Beginning" is the cash position we finished the previous month with.
- "Threshold" is the cash set aside equal to 1/2 (6 Months) of the 2023 budget approved in November 2022.
- "Working Cash" is money in the "Total Cash Position" minus "Threshold."
- "Total Cash Position" is all available cash including the Threshold.

Looking at July, our beginning cash position was \$11,886.78. Less "Threshold" gave us a net working cash position of \$1,949.28.

Contributions from groups in July were \$1,593.37 and we had \$51.00 in Grapevine Sales. Expenses in July were \$2,466.73.

DCM had expenses of \$89.55 – Leaving a remaining budget of: \$3,278.29

Treasurer had expenses of \$0 – Leaving a remaining budget of: \$254.00

Access had expenses of \$0 – Leaving a remaining budget of: \$118.01

Archives had expenses of \$102 - Leaving a remaining budget of: \$1,894.00

Literature Chair had expenses of \$97.04 – Leaving a remaining budget of: \$-6.83

Cooperation with Correctional Facilities had expenses of \$1,190.35 - Leaving a remaining budget of: \$578.65.

Cooperation with Professional Community had expenses of \$80.04 - Leaving a remaining budget of \$569.47.

Cooperation with Treatment Facilities had expenses of \$277.80 – Leaving a remaining budget of \$659.92

Grapevine/La Vina had expenses of \$0 - Leaving a remaining budget of \$242.00

Public Information had expenses of \$609.50 – Leaving a remaining budget of \$2,164.76.

Website had expenses of \$0 – Leaving a remaining budget of \$660

Workshops had expenses of \$20.45 -- remaining budget of \$2,572.96

This leaves us with an ending Total Cash Position of \$11,064.42. After Threshold is set aside, we have \$1,126.92 Working Cash available for August.

We continue to come up short on monthly group contributions compared to the 2023 budget leaving us behind YTD by \$2,453.88

September is a good month, since that gives the new G.S.R. time to study the responsibilities of the job before taking office — most often on January 1, along with the new D.C.M.s and the new

## Cooperation with the Professional Community (CPC): Ron B.

It's been a great month for a District 5 CPC and PI! We've (Carrie and I) developed a new trifold handout for public information. This idea came from the Salem district PI/CPC chair! Thanks! We were able to obtain a booth at the Bend Drake Park mental health fair for today. Hopefully, a lot of outreach to professionals, and maybe a few of us still in our cups.

I've been able to approach the Vet Center who was very interested in having our new trifolds available to veterans in need. They have a prominent place in the office to display them. We also met Jade from Mosaic Health, who is a substance-abuse navigator. She's very interested in learning about AA for her clients. We will be emailing and texting each other. I suggested AA Comes of Age as a way to understand where and how AA developed and who we are today. We also gave her the AA Group Pamphlet to understand our structure and traditions. She was very very receptive! Hopefully she will take advantage of a presentation for her employees. She and Jena will be in contact to get public information pamphlets and other information to Mosaic's clients.

I was able to connect with Dr. Ford of Deschutes Acupuncture who treats alcoholism, and addiction She seemed very receptive to meeting and perusing our CPC Healthcare Professionals packet. Also connected with a group called ALSO, who provide housing for disabled and elderly. She stated they have several people who have problems with alcohol and was excited about available AA resources.

I have also asked two healthcare insurance companies to give our Healthcare Professionals packets to their providers. Fingers crossed. I want to thank not only Jena for her help, but also Irving, Susan, and Erin, who have showed up to do service at our booth.

#### Treatment Facilities (TF): Brian W

Greetings District 5,

Our committee is starting to pick up steam again, but we still have a lot of work to do.

I attended our district's Unity Day event on August 5th and announced that we need more committee members. Several different people came to me, asked questions, shared their willingness to join the committee, and took copies of the flyers describing the service commitment.

I have also produced a draft of proposed Bridging the Gap guidelines to add to our district guidelines. Bridging the Gap is a framework for connecting people coming out of treatment to their first AA meeting by pairing them up with members of the AA community in their area. #### Weathering the Storm (Chris P - GSR)

This monthly report is on behalf of Weathering the Storm, which meets Monday–Friday, 7-8am, at Miller's Landing park (Bend). We host an outdoor meeting experience, year-around, and regardless of the weather conditions. If you visit our group, bring a camp chair and dress for the weather.

There are no chewy issues to report, as the meetings during the past month have been carried out smoothly. That is typical for our group, as we keep our meetings on-task, by the book, and drama-free.

Accordingly, this report is brief and rather uninteresting.

- At the recent Business Meeting, the Group supported the GSR position by allocating the estimated funds needed to cover GSR travel and food expenses for the September and November, 2023 Assemblies.
- We are contemplating the election of an Alternate GSR, although that will become more relevant starting January 1st, 2024 (when my role moves from interim to Full-Monty status). Having an Alternate GSR and an Interim GSR seems excessive for such a small group until the next full term begins.
- We have a new, 2-year Treasurer, and he is getting his sea legs on the service role. Our "up-chain distribution plan" is currently "in the workshop" and is subject to information we learn from District 5 meetings. The specific percentages will be updated at our next business meeting in approximately three (3) weeks. Funds will be portioned across GSO, District 5, and Intergroup. The group is not sending money to Area 58 (due to reported over-funding).
- It has been awkward at times when Committee members, or other people who do not normally attend our meetings, show up and (in combination) make a stack of announcements without learning what our information distribution practices are and/or without coordinating with the GSR, IGR, or meeting Secretary in advance. This is especially true when the event or opportunity is far off (i.e. weeks or more) in the future. Our group gets "announcement burnout" quickly and it can disturb the flow and timing of our meetings. We try to avoid that.
- o As GSR, I have established a clipboard system that includes event flyers, committee flyers, and other timely information. This "mobile bulletin board" is circulated during the meeting and folks take photos of things that spark their interest. If there is something happening today or in the very immediate future, I mention it to the group as a reminder and refer to the flyers they have already seen circulated.

#### **Home Away From Home (Tim C)**

The Home Away From Home Group (HAFHG) of Alcoholics Anonymous is a registered AA Group in District 5, Area 58. We meet every Thursday, from 7-8:30pm, and Sunday, from 2-3:30pm, in Deer Ridge Correctional Institute (DRCI) -- a men's medium security prison near Madras OR. Current meeting attendance ranges between ~20-50 inmates of varying lengths of sobriety. Thursday meetings are AA literature based. The third Sunday is an outside-speaker/ open discussion meeting. The fourth Sunday is an inside-speaker/ open discussion meeting. Other Sundays are open discussion meetings. The first Sunday of the month we hold our business meeting and also celebrate milestones in sobriety.

Since the July 2023 District 5 meeting, the HAFHG has Spiritually considered – through reading, discussing, and sharing experiences grounded in our Big Book and 12&12 – Steps 1, 2, 3, and part of 4 during our Thursday night meeting. In our Sunday meetings, the topic of Sponsorship was considered; a newer volunteer shared his Experience, Strength, and Hope for our outside-speaker meeting; the Daily Reflections provided the Spiritual threads around which meetings on the fourth and fifth Sindays were woven; and, we celebrated milestones of Sobriety and held our business meeting last week.

At our business meeting, we further discussed the manner in which our inside-members will be able to directly contribute financially toward purchasing AA literature and other supplies the Group decides it needs, as well making contributions to others facets of the AA Service Structure and Central Oregon Intergroup of Alcoholics Anonymous (COIGAA). We hope to have our new, cooperative system in place this month. Also of note, our inside-GSR stepped down as his availability and thus capability to fulfill the responsibilities of this position will soon change. We hope to elect a new inside-GSR at our September business meeting. Also on the docket for September, we aim to discuss whether the District 5 meeting or COIGAA meeting will be the preferred venue for our Group to connect with and be informed of happenings in other nearby AA Groups. Our concern is that the criteria for Participation at District 5 meetings potentially hampers the sharing of Group experience, based on a rule. To help inform our Group, our outside-members will alternate between attending the District 5 and COIGAA meetings as proxies in the coming months. The limited number of outside-members, as well as the overlapping times of District & Intergroup meetings with our Homegroup meeting, does not currently allow us to attend both District & Intergroup meetings on a monthly basis. We do, however, plan to submit monthly reports to District 5, as well as have our outside-GSR attend Area Assemblies. Whatever our Group Conscious may become regarding this matter, consideration of Tradition Two and Three, as well as the Spiritual bedrock the 2nd Tradition affords the entire interweaving of our 12 Concepts will no doubt be considered at our upcoming Business meetings, as well as during our Thursday night literature study.
